## I/WE (also referred to as the “Guarantor/s”) UNCONDITIONALLY AND IRREVOCABLY:

- GUARANTEE** the due and punctual payment to the Owner of all monies which are now owing to the Owner by the Client and all further sums of money from time to time owing to the Owner by the Client in respect of equipment and services supplied or to be supplied by the Owner to the Client or any other liability of the Client to the Owner, and the due observance and performance by the Client of all its obligations contained or implied in any contract or agreement with the Owner, including but not limited to the Terms & Conditions of Hire signed by the Client and annexed to this Guarantee and Indemnity. If for any reason the Client does not pay any amount owing to the Owner, the Guarantor will immediately on demand pay the relevant amount to the Owner. In consideration of the Owner agreeing to supply the equipment and/or services to the Client, the Guarantor charges all of its right, title and interest (joint or several) in any land, realty or other assets capable of being charged, owned by the Guarantor now or in the future, to secure the performance by the Guarantor of its obligations under this Guarantee and Indemnity (including, but not limited to, the payment of any money) and the Guarantor acknowledges that this personal guarantee and indemnity constitutes a security agreement for the purposes of the Personal Property Securities Act 2009 (“PPSA”) and unequivocally consents to the Owner registering any interest so charged. Furthermore, it is agreed by both parties that where the Guarantor is acting in the capacity as a trustee for a trust, then the Guarantor agrees to charge all its right title and interest in any land realty, or other assets capable of being charged in its own capacity and in its capacity as trustee and shall be subject to the PPSA Registration as stated above. The Guarantor irrevocably appoints the Owner and each director of the Owner as the Guarantor’s true and lawful attorney/s to perform all necessary acts to give effect to this clause including, but not limited to, signing any document on the Guarantor’s behalf which the Owner may reasonably require to:
  - register a financing statement or financing change statement in relation to a security interest on the Personal Property Securities Register;
  - register any other document required to be registered by the PPSA or any other law; or
  - correct a defect in a statement referred to in clause 1(a) or 1(b).
- HOLD HARMLESS AND INDEMNIFY** the Owner on demand as a separate obligation against any liability (including, but not limited to damages, costs, losses, and legal fees calculated on a solicitor and own client basis) incurred by, or assessed against, the Owner in connection with:
  - the supply of equipment and/or services to the Client; or
  - the recovery of monies owing to the Owner by the Client including the enforcement of this Guarantee and Indemnity, and including but not limited to the Owner’s nominees contract default fee and legal costs; or
  - monies paid by the Owner with the Client’s consent in settlement of a dispute that arises or results from a dispute between, the Owner, the Client, and a third party or any combination thereof, over the supply of equipment and/or services by the Owner to the Client.

## I/WE FURTHER ACKNOWLEDGE AND AGREE THAT

- I/We have received, read, and understood the Owner’s Terms and Conditions prior to entering into this Guarantee and Indemnity and agree to be bound by those Terms and Conditions.**
- This Guarantee and Indemnity shall constitute an unconditional and continuing Guarantee and Indemnity and accordingly shall be irrevocable and remain in full force and effect until all monies owing to the Owner by the Client and all obligations herein have been fully paid satisfied and performed.
- No granting of credit, extension of further credit, or granting of time and no waiver, indulgence, or neglect to sue on the Owner’s part (whether in respect of the Client or any one or more of any other Guarantor(s) or otherwise) and no failure by any named Guarantor to properly execute this Guarantee and Indemnity shall impair or limit the liability under this Guarantee and Indemnity of any Guarantor. (c) maintain the Equipment as is required by the Owner (including, but not limited to, maintaining (where applicable) water, oil and fluid levels and tyre pressures);

11.1

(d) operate the Equipment safely, strictly in accordance with the law, only for its intended use, and in accordance with any manufacturer's instruction whether supplied by the Owner or posted on the Equipment;

11.1

(e) ensure that:

11.1

(i) all persons operating or erecting the Equipment are suitably instructed in its safe and proper use and where necessary hold a current Certificate of Competency and/or are fully licensed to operate the Equipment and shall provide evidence of the same to the Owner upon request;

11.1

(ii) the operator of any Equipment is not under the influence of alcohol or any drug that may impair their ability to operate the Equipment;

11.1

(iii) all reasonable care is taken by the driver in handling and/or parking the Equipment and that the Equipment is left locked and/or securely stored when not in use.

11.1

(f) be liable for any parking or traffic infringement, impoundment, towage and storage costs incurred during the hire period and will supply relevant details as required by the Police and/or the Owner relating to any such matters or occurrences;

11.1

(g) comply with all work health and safety laws relating to the Equipment and its operation;

11.1

(h) on termination of the hire, deliver the Equipment complete with all parts and accessories, clean and in good order as delivered, fair wear and tear accepted, to the Owner (or the Owner's designated employee);

11.1

(i) refuel the Equipment prior to its return from hire. In the event the Equipment needs to be refuelled upon its return from hire then the costs of refuelling shall be charged to the Client in addition to the costs of the Equipment hire;

11.1

(j) keep the Equipment in their own possession and control and shall not assign the benefit of the hire Contract nor be entitled to lien over the Equipment;

11.1

(k) employ the Equipment solely in its own work and shall not permit the Equipment of any part thereof to be used by any other party for any other work; and

11.1

(l) indemnify and hold harmless the Owner in respect of all claims arising out of the Client's use of the Equipment.

11.2

The Client shall not:

11.2

(a) alter or make any additions to the Equipment including but without limitation altering, make any additions to, defacing or erasing any identifying mark, plate or number on or in the Equipment or in any other manner interfere with the Equipment;

11.2

(b) exceed the recommended or legal load and capacity limits of the Equipment (including the recommended number of passengers (if applicable));

11.2

(c) carry any animals, illegal, prohibited or dangerous on, or in, the Equipment supplied without the prior written permission of the Owner; use or carry any illegal, prohibited or dangerous substance in or on the Equipment; or

11.2

(d) use the Equipment for sand blasting or to apply shotcrete; or

11.2

(e) fix any of the Equipment in such a manner as to make it legally a fixture forming part of any freehold.

11.3

Immediately on request by the Owner the Client will pay:

11.3

(a) all costs incurred in cleaning the Equipment; and/or

11.3

(b) the cost of fuels and consumables provided by the Owner and used by the Client;

11.3

(c) any:

11.3

(i) lost hire fees the Owner would have otherwise been entitled to for the Equipment, under this, or any other hire agreement;

11.3

(ii) costs incurred by the Owner in picking up and returning the Equipment to the Owner's premises if the Client does not return the Equipment to the Owner's premises or any pre-agreed pickup location when it was originally agreed that the Client would do so; and/or

12.

**Cancellation**

12.1

Without prejudice to any other remedies the parties may have, if at any time either party is in breach of any obligation (including those relating to payment) under these terms and conditions ("the Breaching Party") the other party may suspend or terminate the supply of Services/Equipment on hire to the other party, with immediate effect, by providing the Breaching Party with written notice. Neither party shall be liable for any costs associated with a party suspending/cancelling the Contract under this clause 12.1.

12.2

If the Owner, due to reasons beyond the Owner's reasonable control, is unable to deliver any Services/Equipment to the Client, the Owner may cancel any Contract to which these terms and conditions apply or cancel Delivery of the Services/Equipment at any time before the Services/Equipment are delivered by giving written notice to the Client. On giving such notice, the Owner shall repay to the Client any money paid by the Client for the Services/Equipment to be hired. The Owner shall not be liable for any loss or damage whatsoever arising from such cancellation.

12.3

The Client may cancel Delivery of the Services/Equipment by written notice served within forty-eight (48) hours of placement of the order. If the Client cancels Delivery in accordance with this clause 12.3, the Client will not be liable for the payment of any costs of the Owner, except where a deposit is payable in accordance with clause 5.4.

13.

**Default and Consequences of Default**

13.1

Interest on overdue invoices shall accrue daily from the date when payment becomes due, until the date of payment, at a rate of two and one half percent (2.5%) per calendar month (and at the Owner's sole discretion such interest shall compound monthly at such a rate) after as well as before any judgment.

13.2

If the Client owes the Owner any money, the Client shall indemnify the Owner from and against all costs and disbursements:

13.2

(a) incurred; and/or

13.2

(b) which would be incurred and/or

13.2

(c) for which by the Client would be liable;

13.2

in regard to legal costs on a solicitor and own client basis incurred in exercising the Owner's rights under these terms and conditions, internal administration fees, the Owner's contract fees owing for breach of these terms and conditions', including, but not limited to, contract default fees and/or recovery costs (if applicable), as well as bank dishonour fees. Further to any other rights or remedies the Owner may have under this Contract, if the Client has made payment to the Owner, and the transaction is subsequently reversed, the Client shall be liable for the amount of the Client's transaction, in addition to any further costs incurred by the Owner under this clause 13 where it can be proven that such reversal is found to be illegal, fraudulent or in contravention to the Client's obligations under this Contract.

13.4

Without prejudice to the Owner's other remedies at law the Owner shall be entitled to cancel all or any part of any order of the Client which remains unperformed and all amounts owing to the Owner shall, whether or not due for payment, become immediately payable in the event that:

13.4

(a) any money payable to the Owner becomes overdue, or in the Owner's opinion the Client will be unable to meet its payments as they fall due; or

13.4

(b) the Client has exceeded any applicable credit limit provided by the Owner;

13.4

(c) the Client becomes insolvent, convenes a meeting with its creditors or proposes or enters into an arrangement with creditors, or makes an assignment for the benefit of its creditors; or

13.4

(d) a receiver, manager, liquidator (provisional or otherwise) or similar person is appointed in respect of the Client or any asset of the Client.

14.

**Compliance with Laws**

14.1

The Client and the Owner shall comply with the provisions of all statutes, regulations and bylaws of government, local and other public authorities that may be applicable to the Services/Equipment.

15.

**Privacy Policy**

15.1

All emails, documents, images or other recorded information held or used by the Owner is Personal Information, as defined and referred to in clause 15.3, and therefore considered Confidential Information. The Owner acknowledges its obligation in relation to the handling, use, disclosure and processing of Personal Information pursuant to the Privacy Act 1988 ("the Act") including the Part IIC of the Act being Privacy Amendment (Notifiable Data Breaches) Act 2017 (NDB) and any statutory requirements, where relevant in a European Economic Area ("EEA"), under the EU Data Privacy Laws (including the General Data Protection Regulation "GDPR") (collectively, "EU Data Privacy Laws"). The Owner acknowledges that in the event it becomes aware of any data breaches and/or disclosure of the Client's Personal Information, held by the Owner that may result in serious harm to the Client, the Owner will notify the Client in accordance with the Act and/or the GDPR. Any release of such Personal Information must be in accordance with the Act and the GDPR (where relevant) and must be approved by the Client by written consent, unless subject to an operation of law.

15.2

Notwithstanding clause 15.1, privacy limitations will extend to the Owner in respect of Cookies where the Client utilises the Owner's website to make enquiries. The Owner agrees to display reference to such Cookies and/or similar tracking technologies, such as pixels and web beacons (if applicable), such technology allows the collection of Personal Information such as the Client's:

15.2

(a) IP address, browser, email client type and other similar details;

15.2

(b) tracking website usage and traffic; and

15.2

(c) reports are available to the Owner when the Owner sends an email to the Client, so the Owner may collect and review that information ("collectively Personal Information").

15.2

If the Client consents to the Owner's use of Cookies on the Owner's website and later wishes to withdraw that consent, the Client may manage and control the Owner's privacy controls via the Client's web browser, including removing Cookies by deleting them from the browser history when exiting the site. The Client agrees for the Owner to obtain from a credit reporting body (CRB) a credit report containing personal credit information (e.g. name, address, D.O.B, occupation, driver's license details, electronic contact (email, Facebook or Twitter details), medical insurance details or next of kin and other contact information (where applicable), previous credit applications, credit history) about the Client in relation to credit provided by the Owner.

15.4

The Client agrees that the Owner may exchange information about the Client with those credit providers and with related body corporates for the following purposes:

15.4

(a) to assess an application by the Client; and/or

15.4

(b) to notify other credit providers of a default by the Client; and/or

15.4

(c) to exchange information with other credit providers as to the status of this credit account, where the Client is in default with other credit providers; and/or

15.4

(d) to assess the creditworthiness of the Client including the Client's repayment history in the preceding two (2) years.

15.8

The Client consents to the Owner being given a consumer credit report to collect personal credit information relating to any overdue payment on commercial credit.

15.6

The Client agrees that personal credit information provided may be used and retained by the Owner for the following purposes (and for other agreed purposes or required by):

15.6

(a) the provision of Equipment; and/or

15.6

(b) analysing, verifying and/or checking the Client's credit, payment and/or status in relation to the provision of Equipment; and/or

15.9

(c) processing of any payment instructions, direct debit facilities and/or credit facilities requested by the Client; and/or

15.7

(d) enabling the collection of amounts outstanding in relation to the Equipment.

15.7

The Owner may give information about the Client to a CRB for the following purposes:

15.7

(a) to obtain a consumer credit report; and/or

15.7

(b) allow the CRB to create or maintain a credit information file about the Client including credit history.

15.8

The information given to the CRB may include:

15.8

(a) Personal Information as outlined in 15.3 above;

16.

**Building and Construction Industry Security of Payments Act 1999**

16.1

At the Owner's sole discretion, if there are any disputes or claims for unpaid Equipment and/or Services then the provisions of the Building and Construction Industry Security of Payments Act 1999 may apply.

16.2

Nothing in this Contract is intended to have the effect of contracting out of any applicable provisions of the Building and Construction Industry Security of Payments Act 1999 of New South Wales, except to the extent permitted by the Act where applicable.

17.

**Service of Notices**

17.1

Any written notice given under this Contract shall be deemed to have been given and received:

17.1

(a) by handing the notice to the other party, in person;

17.1

(b) by leaving it at the address of the other party as stated in this Contract;

17.1

(c) by sending it by registered post to the address of the other party as stated in this Contract;

17.1

(d) if sent by facsimile transmission to the fax number of the other party as stated in this Contract (if any), on receipt of confirmation of the transmission; or

17.2

(e) if sent by email to the other party's last known email address.

17.2

Any notice that is posted shall be deemed to have been served, unless the contrary is shown, at the time when by the ordinary course of post, the notice would have been delivered.

18.

**Trusts**

18.1

If the Client at any time upon or subsequent to entering in to the Contract is acting in the capacity of trustee of any trust or as an agent for a trust ("Trust") then whether or not the Owner may have notice of the Trust, the Client covenants with the Owner as follows:

18.1

(a) the Contract extends to all rights of indemnity which the Client now or subsequently may have against the Trust, the trustees and the trust fund;

18.1

(b) the Client has full and complete power and authority under the Trust or from the Trustees of the Trust as the case may be to enter into the Contract and the provisions of the Trust do not purport to exclude or take away the right of indemnity of the Client against the Trust, the trustees and the trust fund. The Client will not release the right of indemnity or commit any breach of trust or be a party to any other action which might prejudice that right of indemnity;

18.1

(c) the Client will not during the term of the Contract without consent in writing of the Owner (the Owner will not unreasonably withhold consent), cause, permit, or suffer to happen any of the following events:

18.1

(i) the removal, replacement or retirement of the Client as trustee of the Trust;

18.1

(ii) any alteration to or variation of the terms of the Trust;

18.1

(iii) any advancement or distribution of capital of the Trust; or

18.1

(iv) any resettlement of the trust fund or trust property.

19.

**General**

19.1

Any dispute or difference arising as to the interpretation of these terms and conditions or as to any matter arising herein, shall be submitted to, and settled by, mediation before resorting to any external dispute resolution mechanisms (including arbitration or court proceedings) by notifying the other party in writing setting out the reason for the dispute. The parties shall share equally the mediation fees. Should mediation fail to resolve the dispute, the parties shall be free to pursue other dispute resolution avenues. The failure by either party to enforce any provision of these terms and conditions shall not be treated as a waiver of that provision, nor shall it affect that party's right to subsequently enforce that provision. If any provision of these terms and conditions shall be invalid, void, illegal or unenforceable, that provision shall be severed from this Contract, and the validity, existence, legality and enforceability of the remaining provisions shall not be affected, prejudiced or impaired.

19.3

These terms and conditions and any contract to which they apply shall be governed by the laws of New South Wales, the state in which the Owner has its principal place of business and are subject to the jurisdiction of the courts in that state.

19.4

The Owner may licence and/or assign all or any part of its rights and/or obligations under this Contract without the Client's consent provided the assignment does not cause detriment to the Client.

19.5

The Client cannot assign or licence without the written approval of the Owner.

19.6

The Owner may elect to subcontract out any part of the provision services but shall not be relieved from any liability or obligation under this Contract by so doing. Furthermore, the Client agrees and understands that they have no authority to give any instruction to any of the Owner's sub-contractors without the authority of the Owner.

19.7

The Client agrees that the Owner may amend their general terms and conditions for such future contracts with the Client by disclosing such to the Client in writing. These changes shall be deemed to take effect from the date on which the Client accepts such changes, or otherwise at such time as the Client makes a further request for the Owner to provide Services/Equipment on hire to the Client.

19.8

Neither party shall be liable for any default due to any act of God, war, terrorism, strike, lock-out, industrial action, fire, flood, storm, national or global pandemics and/or the implementation of regulation, directions, rules or measures being enforced by Governments or embargo, including but not limited to, any Government imposed border lockdowns (including, worldwide destination ports), etc. ("Force Majeure") or other event beyond the reasonable control of either party. This clause does not apply to a failure by the Client to make payment to the Owner, once the parties agree that the Force Majeure event has ceased.

19.9

Both parties warrant that they have the power to enter into this Contract and have obtained all necessary authorisations to allow them to do so, they are not insolvent and that this Contract creates binding and valid legal obligations on them.

19.10

The rights and obligations of the parties will not merge on completion of any transaction under this Contract, and they will survive the execution and delivery of any assignment or other document entered, for the purpose of, implementing any transaction under this Contract.

19.11

If part or all of any term of this Contract is or becomes invalid, illegal or unenforceable, that term shall be severed from this Contract and shall not affect the validity and enforceability of the remaining terms of this Contract.

(b)

name of the credit provider and that the Owner is a current credit provider to the Client;

(c)

whether the credit provider is a licensee;

(d)

type of consumer credit;

(e)

details concerning the Client's application for credit or commercial credit (e.g. date of commencement/termination of the credit account and the amount requested);

(f)

advice of consumer credit default (provided the Owner is a member of an approved OAIC External Disputes Resolution Scheme) overdue accounts, loan repayments or outstanding monies which are overdue by more than sixty (60) days and for which written notice for request of payment has been made and debt recovery action commenced or is about to be commenced; and the Client no longer has any overdue accounts and the Owner has been paid or otherwise discharged and all details surrounding that discharge (e.g. date of payments);

(g)

information that, in the opinion of the Owner, the Client has committed a serious credit infringement; or

(h)

advice that the amount of the Client's overdue payment is equal to or more than one hundred and fifty dollars (\$150).

The Client shall have the right to request (by e-mail) from the Owner:

(a)

a copy of the Personal Information about the Client retained by the Owner and the right to request that the Owner correct any incorrect Personal Information; and

(b)

the Owner does not disclose any Personal Information about the Client for the purpose of direct marketing.

The Owner will destroy Personal Information upon the Client's request (by e-mail) or if it is no longer required unless it is required in order to fulfil the obligations of this Contract or is required to be maintained and/or stored in accordance with the law.

The Client can make a privacy complaint by contacting the Owner via e-mail. The Owner will respond to that complaint within seven (7) days of receipt and will take all reasonable steps to make a decision as to the complaint within thirty (30) days of receipt of the complaint. In the event that the Client is not satisfied with the resolution provided, the Client can make a complaint to the Information Commissioner at [www.oaic.gov.au](http://www.oaic.gov.au).
